

BLACK FRIDAY Prize Giveaway

Terms and Conditions

1. ORGANISER OF THE GAME

Only customers of AutoAZ who meet the conditions defined in Section 2 may participate in the BLACK FRIDAY Prize Draw (hereinafter: “Prize Draw”), organised by UNIX Autó Kft. (Registered address: 1139 Budapest, Frangepán u. 55–57., E-mail: cs@unixauto.com, hereinafter: “Organiser”).

2. PARTICIPANTS

Only those AutoAZ customers are eligible to participate in the Prize Draw who meet the promotional requirement announced for the BLACK FRIDAY Prize Draw between 24 November 2025 and 7 December 2025, meaning they purchased goods worth at least €100 (gross) from autoaz.at, autoaz.de or autoaz.com during the promotion period. Each participant will be entered into the draw only once.

3. EXCLUSION CRITERIA

Employees, managers, and their relatives—defined under § 8:1 (1) point 2 of the Hungarian Civil Code—of the Organiser are excluded from participating.

4. REGISTRATION FOR THE GAME

If an AutoAZ customer meets the promotional requirement—that is, purchases goods worth at least €100 (gross) during the promotion period on autoaz.at, autoaz.de or autoaz.com—they are automatically entered into the Prize Draw.

By participating, the participant accepts all terms and conditions set forth in these Rules.

5. DURATION OF THE GAME

The promotion underlying the Prize Draw runs from 24 November 2025 to 7 December 2025.

The draw will take place on 2nd week of December, in the presence of a public notary.

6. PRIZES AND DRAW

Within the framework of the Prize Draw, 3 Milwaukee M12 FPD2-202X cordless percussion drills will be raffled among participating AutoAZ customers.

Prizes are non-transferable, cannot be exchanged for cash, and cannot be substituted.

To the maximum extent permitted by applicable law, the Organiser excludes all liability for any circumstances or consequences arising after the prize is handed over, including matters related to use of the prize by the winner or any third party.

The Organiser undertakes to hand over the prizes but accepts no liability for their quality, and excludes any warranty, compensation or other claims to the fullest extent legally permitted.

The winner may submit warranty or other claims only to the manufacturer of the prize. The Organiser will provide reasonable assistance in this process.

7. HANDOVER OF PRIZES

The Organiser will notify winners within seven (7) working days after the draw, using the e-mail address provided at the time of purchase, and will provide details regarding prize collection.

If the participant is considered a person with limited legal capacity, they may manage, collect, or use the prize only together with their legal representative or guardian.

8. TAXES

Any income tax obligations arising from the prize shall be borne by the Organiser. The Organiser has no obligations beyond handing over the prize.

9. DATA PROTECTION

Participants acknowledge and expressly agree that in the event of winning, their name and place of residence (town only) may be published by the Organiser solely in connection with the Prize Draw, without further conditions or compensation.

By participating, they expressly accept all provisions of these Terms and Conditions.

Regarding the processing of personal data submitted by participants, the Organiser acts as data controller, data user and data processor.
